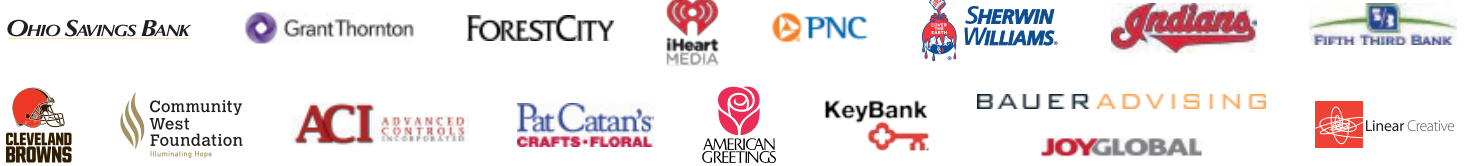

Elisabeth's House!

Elisabeth's House: The Prentiss Wellness Nursery supports children in crisis who also have medical needs. Since opening in November 2015, the Wellness Nursery has served 33 children from 21 families and the children we've cared for have these conditions:

- Asthma
- Autism
- Autoimmune Allergies
- Cardiovascular Issues
- Cerebral Palsy
- Elevated Lead Levels
- Failure to Thrive
- Gastrointestinal Disorders
- Narcotic Weaned Infants
- Premature Infants
- Sickle Cell Disease
- Spina Bifida
- Stroke

Child Outcomes

88% of children cared for in the Wellness Nursery were not readmitted to the hospital during their stay at Providence House.

89% of children served were reunified with their parent or guardian.



Parent Outcomes

100% of parents reported their bond with their child stayed the same or improved during their engagement with our services.

89% of parents felt their parenting skills had improved during their engagement with Providence House.

89% of parents felt their family stability increased during their engagement with Providence House.

Children staying in our traditional Crisis Nursery receive a well-child exam in the Wellness Nursery's pediatric exam room. The exam room equipment was purchased through a grant from the Ronald McDonald House Charities of Northeastern Ohio. We are grateful for their support, which has helped us to provide over 250 well-child exams in the past year!
